Orgon, June 23rd 2022 - ID Logistics (ISIN: FR0010929125, code: IDL), one of the European leaders in contract logistics, announces its membership in EcoTransIT World as part of a commitment to corporate sustainability. More specifically, EcoTransIT World is a tool that allows the calculation of transport on all its activities around the world by including parameters such as fuel consumption, carbon emissions or air pollutants, while allowing the comparative analysis of this data.

The tool fully calculates global transport chains of all kinds, whether by trucks, ships, planes, trains or waterways. In order to extract data that shows the environmental impact, the tool analyzes indicators such as the means of transport or the route taken and uses information such as the type of refuelling, environmental factors or attributes like the type of road. Finally, the tool collects data on emissions and energy consumption.

A METHODOLOGY COMPATIBLE WITH INTERNATIONAL STANDARDS

The methodology used by EcoTransIT includes calculation compatible with EN 16258, a methodology for calculating and reporting energy consumption and greenhouse gas emissions in transport services (freight and passenger transport) and with the standards of the World Logistics Emission Board (GLEC). In the same way, it will also comply with the requirements of the ISO14083 standard, on greenhouse gas emissions from transport chain operations.

A COMMITMENT TO THE PLANET BEYOND ECOTRANSIT WORLD

Other challenges proposed by ID Logistics for 2030 are to reduce emissions from logistics activities (CO₂ / pallet) by 40% Scope 1 & 2 compared to 2018 and to reduce the energy intensity of logistics activities by 20% (kWh/M²) by also taking 2018 as a region.

In this sense, with the development of projects of this nature, ID Logistics is positioning itself as one of the responsible actors in the process of transformation of the sector and reinforces its commitment to the preservation of the environment and the reduction of the impact of its activity.
