In 2000, he joined Freelog Consulting as Vice President (Paris) and President of Atlas Logistics (Casablanca). In 2003, William Parramore joined Kuehne+Nagel, where he was successively Head of Contract Logistics France, Region Vice President Sales Director South-West Europe and, finally, Senior Vice President Regional Head for Contract Logistics. From 2015 to 2021, William Parramore held numerous positions such as Global Senior Vice President at CMA CGM Logistics, Head of Sales Europe at Damco, then Independent Consultant for logistics players.
