- Diageo, the world leader in alcoholic beverages, combines three of its sites into one, entirely managed by ID Logistics.
- Ypê, a Brazilian brand of hygiene and cleaning products, also chooses to outsource its logistics activities and entrust them to the logistician.

Recognized for its values of operational excellence, technology and innovations, particularly well adapted to the dynamics of the country, ID Logistics Brazil has established itself in the country as the leader in logistics management for consumer goods industries (cosmetics, hygiene, alcohol) as well as distribution and e-commerce players. With more than 4,000 employees and 1,000,000 m² of warehouses, the logistician aims to rapidly expand its operations throughout Brazil.

THREE SITES COMBINED INTO ONE PLATFORM FOR DIAGEO

Diageo, world leader in alcoholic beverages, wanted to consolidate three of its logistics sites into a single platform dedicated to the Brazilian market. Entirely managed by ID Logistics and operational since the beginning of 2023, this 18,000 m² site manages nearly 200 product references, for a volume of 27,000,000 parcels per year.

In order to meet the need for efficiency and monitoring expressed by Diageo, ID Logistics has implemented many



technological solutions: a WMS to ensure optimal and accurate inventory management, electronic checklists for visibility of incoming and outgoing volumes, digital activity monitoring for real-time sharing of site activities at Diageo, drones for carrying out inventories or the use of lithium-ion batteries to reduce carbon emissions.

A NEW 12,000 M² PLATFORM FOR YPÊ

The Brazilian brand of cleaning products Ypê chose ID Logistics for its perfect knowledge of the Extrema region as well as for its ability to launch a new activity in a very short time.

The 12,000 m² site will be operational by April 2023, bringing together 320 references and shipping 650,000 parcels per year. Solutions have also been



implemented for operations management such as a WMS developed by ID Logistics for Ypê, but also other technologies to monitor site activity in real time and make inventory management more reliable.
