ID LOGISTICS EXTENDS ITS IDEO CONTROL TOWER IN EUROPE

ID Logistics, leader in contract logistics in France and internationally, extends its IDEO control tower in Europe thanks to the creation of a subsidiary in Poland. The latter reinforces the historical activity, based in Saint-Priest (69), with about thirty additional supply chain managers. From 2024, IDEO will manage more than 500,000 transport orders (TO) per year (compared to 280,000 in 2022), representing more than €500 million in annual transport purchases for a dozen major European shippers.

An engineering unit set up by IDEO ensures that the optimization of flows perfectly integrates the reduction of the CO2 footprint, particularly through the development of rail-road transport. The ambition is to significantly reduce the carbon footprint of transport, in particular by better filling trucks and trains, and reducing empty kilometers.
- **Reducing costs**, with a centralized, multi-customer purchasing department.
