Established in the United States with the takeover of Jagged Peak's US logistics operations in 2019, ID Logistics, a leading contract logistics group in Europe, strengthened its presence in North America with the acquisition of Kane Logistics in 2022. ID Logistics has almost doubled its size in the United States and now employs more than 6,000 people. It is winning new customers, thanks to its growth model, its know-how, and the synergies it is developing with the Group's other subsidiaries.

ID LOGISTICS: A GROWTH MODEL THAT IS SUCCESSFULLY EXPORTED

The Group started its activity in the country in 2019 with 3 logistics sites specializing in e-commerce. In 2022, the acquisition of Kane Logistics marked a further step for the logistics company, weaving a rich network of 26 sites located across 8 US states. The addition of these two entities to the Group has made it possible to integrate strong skills in the consumer goods and co-packing sectors.

In 2024, thanks to winning new contracts, ID Logistics has strongly developed its operations: now with 47 sites in 18 states, and more than 6,600 employees compared to 2,800 in 2022. This strong growth demonstrates the relevance of the ID Logistics model for American customers, thanks to the quality of the services and solutions offered, the know-how and competence of the subsidiary's American management, but also thanks to the Group's expertise and support.

ID Logistics is now one of the most important American service providers to some of the world's leading FMCG, consumer packaged goods, and food and beverage manufacturing companies, along with a global e-commerce giant.

The business across the Atlantic now represents more than 16% of the Group's business in 2024.
