ID LOGISTICS GAINS GROUND IN GERMANY

In Germany, the ID Logistics Group has around 900,000 sqm of warehouse space and more than 4,500 employees. It offers order picking, warehousing, and distribution services. Thanks to a presence throughout the country, Hamburg, Hanover, Kaiserslautern, Werl, Dortmund, Philippsburg etc., ID Logistics effectively covers the entire country. The company supports major brands, particularly in the e-commerce, furniture, cosmetics and new energy sectors.

Located in a logistics park developed in partnership with Scannell Properties, the Diemelstadt site will be delivered in the 3rd quarter of 2025. It will have a Gold certification according to the standards of the Deutsche Gesellschaft für Nachhaltiges Bauen (DGNB). Its central location and direct access to major European routes will make it a leading logistical asset, operational 24/7.

ID LOGISTICS SUPPORTS THE GROWTH OF AN E-COMMERCE GIANT

As part of this dynamic, ID Logistics announces the signing of a new contract with a major player in e-commerce. From the third quarter of 2025, the supply chain specialist will operate a 68,000 sqm e-commerce order preparation site located in Diemelstadt, Hesse.

Designed according to ESG standards, this latest-generation site will become a major hub for national distribution for an e-commerce giant. It will manage more than 1.9 million references, from single-product to complex orders.

700 EMPLOYEES RECRUITED FOR THIS 15TH SITE

From the start, 300 employees will be mobilized on 4 of the site's 6 units. The ramp-up will continue until 2026 to reach 700 people, in 3x8 operation. ID Logistics will rely on the experience of its existing sites and its proven integration systems to support the ramp-up of the teams.

As part of this new contract, ID Logistics has developed a tailor-made logistics solution that can meet the growing requirements of e-commerce: wide variety of products, fluctuating volumes and ultra-short processing times (same-day order / next-day delivery).

This new contract illustrates the Group's ability to design and implement agile, industrialized and high-performance logistics models, while integrating the real estate, technological and human dimensions.

€20 MILLION INVESTED IN MECHANISATION AND AUTOMATION

To support operational performance, ID Logistics is investing €20 million in state-of-the-art equipment for storage, picking, conveying and automated sorting. The entire system aims to guarantee fast and reliable processing of e-commerce flows on large volumes.

A SITE IN LINE WITH THE LATEST ENVIRONMENTAL STANDARDS

The Diemelstadt site incorporates the latest environmental innovations. It will be equipped with a photovoltaic installation with an estimated capacity of 4.8 MWp, a high-efficiency heat pump system, green roofs, LED lighting and charging stations for electric vehicles.

This project is fully in line with ID Logistics' CSR strategy, combining operational performance and environmental responsibility.
