

ID LOGISTICS DEPLOYS A 100% ELECTRIC FLEET FOR A MAJOR RETAIL PLAYER

In line with its commitment to more responsible logistics and transport, ID Logistics, the international leader in contract logistics, announces the commissioning of a new fleet of 100% electric trucks, specifically designed to meet the logistics needs of a major retail player in the Paris region. This project marks a key step in the Group's energy transition strategy, which is already committed to several initiatives to decarbonize the transport business.

AN ELECTRIC FLEET DESIGNED FOR TRAFFIC AND DISTRIBUTION CONSTRAINTS IN THE ILE-DE-FRANCE REGION

Operated from a site in Seine-et-Marne, this fleet of 10 100% electric trucks has been designed in close collaboration with VOLVO Trucks and IVECO, as part of a technical partnership aimed at meeting the requirements of intensive urban distribution. The fleet includes:

- 3 x 16-tonne VOLVO FL Electric trucks, since the end of 2024.
- 7 lighter IVECO trucks (7.2 tons), on the road since Q2 2025.

This fleet ensures the delivery of consumer products and high-end products to points of sale located in the Paris region 24/7. The logistics organisation is optimised to allow a circular flow: the trucks leave the stores with empty packaging, reducing journeys without goods and thus increasing the overall efficiency of the system.

With an average of 1,200 km driven each day for the entire fleet, and a range of up to 200 km to 300 km depending on the vehicle, this system makes it possible to make up to 100,000 deliveries per year while eliminating local CO_2 emissions. Since their entry into service at the end of last year, the 3 VOLVO trucks have already saved an estimated 26 tonnes of CO_2 .

All vehicles are recharged daily at an electrical station located in front of the site, guaranteeing smooth logistics, without adding unnecessary kilometers. The energy used comes from the French electricity mix and is therefore 95% carbon-free. This integrated charging infrastructure ensures continuous operation of the fleet under optimal performance conditions.

A TAILOR-MADE SOLUTION FOR MORE SUSTAINABLE RETAIL

This project was co-constructed with a strategic retail player as part of the renewal of its transport contract. The latter wanted to go further in its CSR policy by switching all of its regional flows to 100% electric vehicles.

ID Logistics has been able to respond with agility to this need by designing a tailor-made logistics solution that is immediately operational. This approach demonstrates the Group's ability to:

- Integrating low-emission technologies into demanding logistics schemes,
- Ensure local zero-emission urban logistics, including on complex flows,
- Deliver tailor-made solutions in a timely manner, even in continuous operating contexts.

This project illustrates ID Logistics' ambition and its ability to quickly mobilize equipment adapted to the specific needs of its customers, while supporting them in the renewal of their vehicle fleet towards more virtuous energies.
