The multinational logistics operator reinforces its strategy in Brazil with newly signed contracts, strengthening its presence especially in the e-commerce, fashion, and FMCG verticals. By combining innovation and sustainability in its logistics solutions, the company reaffirms what has been its main driver of global growth since its inception: supporting major international clients while simultaneously winning new local customers, who will become the growth engines of tomorrow.



ID Logistics Brazil, a multinational contract logistics operator, recorded strong growth in the national market, more than doubling in size over the past three years. The performance in Brazil mirrors the global momentum of the ID Logistics Group, which reached €3.3 billion in revenue in 2024.
