Further expansion in Russia for ID Logistics to accompany client ATAK

Cavaillon, 10 December 2013 – ID Logistics, one of the French leaders in contract logistics, has confirmed its ambitions for Russia and today marks the opening of a logistics site in Noginsk, 40km from Moscow, rolled out especially for distributor ATAK, a subsidiary of the Auchan Group. This opening thereby confirms the strategy of accompanying its major clients outside France. ID Logistics already operates two logistics sites for Simply Market stores (formerly Atac) in France, in Brétigny-sur-Orge and Saint-Germain-lès-Arpajon, and also manages the retailer's e-commerce platform, Simplymarket.fr, in the Paris region.

This new 12,500 m² site, which commenced operations on 16 September, will allow for the reception and handling of more than 22 million packages a year (fresh foods and fruit and vegetables), seven days a week, 24 hours a day, to serve more than 100 ATAK stores to the north, south and east of Moscow. ID Logistics is therefore providing the ATAK Group with a comprehensive logistics service, comprising:

- A turnkey real estate solution
- Cross-docking logistics at controlled temperatures (2°/4° and 6°/8°)
- Management and optimisation of downstream transportation

The cutting-edge equipment used at the site, such as voice picking and wireless user-friendly handsets, coupled with optimised processes, enables it to offer high service standards and adapt to ATAK's needs in Russia.

Jérôme Jacek, Chief Executive Officer of ID Logistics Russia, comments: "This new opening in Russia will enable us to position the company in a fast-growing country with a high level of demand for structured logistics solutions. With this new project, ID Logistics is in the perfect position to be able to respond to this demand, particularly from supermarkets and hypermarkets and fast-moving consumer goods manufacturers."

Following this announcement, Eric Hémar stated: "This partnership with ATAK marks another success for the Group and attests to our ability to accompany our clients in the expansion of their international operations, particularly in Russia, where we have been present since 2010. It also demonstrates the quality of service offered by our teams, as well as our ability to offer innovative solutions for our clients in all parts of the world and tailored to local requirements."
